## CITY OF CHEVIOT STATE OF OHIO

**ORDINANCE NO. 17 -** 

TO ACCEPT THE BID OF ADLETA CONSTRUCTION FOR THE RECONSTRUCTION OF RUTH, RUCKLE, AND ROSWELL AVENUES; AND TO DECLARE AN EMERGENCY.

**WHEREAS,** on March 7, 2017, by Resolution No. 17-03, this Council authorized the Safety-Service Director to solicit bids for the resurfacing of Ruth, Ruckle and Roswell Avenues; and

WHEREAS, in response to his advertisement, 3 such bids were submitted to the city; and

WHEREAS, the lowest and best bid was submitted by Adleta Construction;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1</u>. The Council hereby accepts the bid submitted by Adleta Construction for the resurfacing of Ruth, Ruckle and Roswell Avenues in the base amount of \$580,387.09. The accepted bid shall be in accordance with the specifications on file in the office of the Safety-Service Director.

<u>Section 2</u>. In the event of unforeseen extra work which might be required, the Safety-Service Director shall not approve any such work which exceeds 10% of the project cost bid without first receiving the authorization of this council.

<u>Section 3</u>. The Safety-Service Director is authorized and directed to enter into the necessary contracts with Adleta Construction in order to carry out the work covered by this bid.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep the city's streets in the safest possible condition.
