ORDINANCE NO. 17 -

TO ACCEPT THE BID OF BARRETT PAVING FOR THE RECONSTRUCTION OF WESTWOOD NORTHERN BOULEVARD; AND TO DECLARE AN EMERGENCY.

WHEREAS, on June 6, 2017, by Ordinance No. 17-15, this Council authorized the Safety-Service Director to enter into an agreement with the Board of Hamilton County Commissioners for the resurfacing of Westwood Northern Boulevard; and

WHEREAS, such agreement authorized the county to solicit bids for the reconstruction subject to the approval of the city; and

WHEREAS, in response to advertisement, bids were submitted to the county; and

WHEREAS, the lowest and best bid was submitted by Barrett Paving; and

WHEREAS, the total amount for the project is \$5,189,802.10 and the City of Cheviot's amount is \$1,751,497.20.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1</u>. The Council hereby accepts the bid submitted by Barrett Paving for the resurfacing of Westwood Northern Boulevard in the total project amount of \$5,189,802.10, and the city's portion of \$1,751,497.20. The accepted bid shall be in accordance with the specifications on file in the office of the Safety-Service Director.

<u>Section 2</u>. The Safety-Service Director is authorized and directed to enter into the necessary contracts with the county and Barrett Paving in order to carry out the work covered by this bid.

<u>Section3.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep the city's streets in the safest possible condition.
