**ORDINANCE NO. 18-11**

**TO AUTHORIZE THE INSTALLATION OF A HISTORICAL MARKER AT HARVEST HOME PARK; TO AUTHORIZE THE AGREEMENT TO MAINTAIN THE HISTORICAL MARKER; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, the City wishes to install an Ohio Historical Marker entitled "The Origins of Harvest Home Park" at Harvest Home Park, located at 3961 North Bend Road, Cheviot, Ohio 45211;

**WHEREAS**, Harvest Home Park is owned by the City, and the City is responsible for its maintenance;

**WHEREAS**, the City's authorization of the installation of the Historical Marker and the City's agreement to maintain the Historical Marker is required for the City to order the Historical Marker; and


**WHEREAS**, the City wishes to immediately order the Historical Marker, so that the Historical Marker may be installed during the City's Bicentennial Year.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**


Section 1. The City authorizes the installation of an Ohio Historical Marker entitled "The Origins of Harvest Home Park" at Harvest Home Park, located at 3961 North Bend Road, Cheviot, Ohio 45211.

Section 2. The City agrees to maintain the Historical Marker so long as the Historical Marker is located on City property.

Section 3. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to order the Historical Marker at the earliest possible time, so that the Historical Marker can be installed, if possible, during the City's Bicentennial Year.
