CITY OF CHEVIOT STATE OF OHIO

ORDINANCE NO. 19-<u>/</u>/

TO AUTHORIZE PAY RAISES FOR CERTAIN FULL-TIME EMPLOYEES; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to raise the pay of certain non-union employees at a rate that is substantially equivalent to the union employees, it is necessary to give said non-union employees an increase in base pay.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1.</u> Beginning May 1, 2019, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Clerk of Courts, the Administrative Assistant, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Clerk shall have their salaries increased by 4%.

<u>Section 2.</u> Beginning May 1, 2020, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Clerk of Courts, the Administrative Assistant, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Clerk shall have their salaries increased by 3.5%.

Section 3. Beginning May 1, 2021, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Clerk of Courts, the Administrative Assistant, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Clerk shall have their salaries increased by 3%.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to fairly compensate the employees listed above at the earliest possible time.
