ORDINANCE NO. 19-

TO AMEND THE 2019 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, it has become necessary to make adjustments to the 2019 annual budget appropriations by increasing and decreasing certain budget line items; and

WHEREAS, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

<u>Section 1.</u> The following budget line items shall be increased by the amount indicated:

The Auditor shall increase the Bicentennial certificate of available resources by \$4,714.65 before Budget Line Item 101.709.252.1 is increased.

Section 3. The sum of \$40,000.00 shall be transferred from the General Fund (No. 101) to the Police and Fire Pension City Share (Fund 701).

<u>Section 4.</u> The sum of \$1,700.00 shall be transferred from the General Fund (No. 101) to the Waste Collection Service Fund (No. 503) for recycling.

Section 5. The sum of \$7,137.00 shall be transferred from the General Fund (No. 101) to the Ambulance Fund (No. 301) for payment.

<u>Section 6.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
