# CITY OF CHEVIOT STATE OF OHIO

## **ORDINANCE NO. 19-32**

TO AMEND THE 2019 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, it has become necessary to make adjustments to the 2019 annual budget appropriations by increasing and decreasing certain budget line items; and

WHEREAS, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

### Section 1. The following budget line items shall be increased by the amount indicated:

<u>Section 4.</u> The sum of \$30,000.00 shall be transferred from the General Fund (No. 101) to Capital Improvement Fund (No. 303).

Section 5. The sum of \$ 17,661.76 shall be transferred from the General Fund (No. 101) to Pool Fund (No. 502).

<u>Section 6</u>. The sum of \$12,000.00 shall be transferred from the General Fund to Police and Fire Pension Fund.

<u>Section 7.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
