ORDINANCE NO. 20-19

**TO AUTHORIZE THE ESTABLISHMENT OF THE COVID RELIEF FUND; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, on June 16, 2020, this Council passed Resolution 20-09 "To Affirm That Funds From the County Coronavirus Relief Distribution Fund will be Expended Only to Cover Costs of the City of Cheviot, Ohio, Consistent With the Requirements of Section 5001 of the Cares Act as Described in 42 U.S.C. 601(D), and any Applicable Regulations as is Necessary Pursuant To H.B. 481 Before Receiving Said Funds; and to Declare An Emergency;" and

**WHEREAS**, Council is required to establish a fund to account for revenues and expenditures associated with the Federal CARES Act and Ohio House Bill 481, of the 133<sup>rd</sup> General Assembly; and

**WHEREAS**, Council wishes to establish the Covid Relief Fund (Fund No. 412).

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**

Section 1. A new fund is hereby established for the revenues and expenditures associated with the Federal CARES Act, and said fund shall identified as Covid Relief Fund (Fund No. 412).

Section 2. The Covid Relief Fund (Fund No. 412) shall be funded by money received pursuant to the Federal CARES Act and Ohio House Bill 481.

Section 3. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary as it was mandated to create this fund in order to separate funds received and expended from the Federal CARES Act, and the City needs these funds at the earliest time possible to meet its financial obligations in a timely manner.


