

**CITY OF CHEVIOT  
STATE OF OHIO**

**ORDINANCE NO. 20-30**

**TO AMEND THE 2020 ANNUAL BUDGET APPROPRIATIONS; TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, it has become necessary to make adjustments to the appropriations of the 2020 annual budget; and

**WHEREAS**, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:**

Section 1. The sum of \$5,000.00 shall be transferred from the General Fund (No. 101) to the Police and Fire Pension Fund for pension payment.

Section 2. The sum of \$7,050.75 shall be transferred from General Fund (No. 101) to Ambulance Fund (No. 301) for payment.

Section 3. The Budget Line Items below shall be increased by the amounts indicated:
