ORDINANCE NO. 21-20

**TO AMEND THE 2021 ANNUAL BUDGET APPROPRIATIONS; CREATE A NEW LINE ITEM;  
AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, it has become necessary to make adjustments to the appropriations of the 2021 annual budget by increasing and decreasing certain budget line items; and

**WHEREAS**, it is necessary to add a line to the General Fund Account for "Hillebrand Property Tax Refund 101.707.270.3."

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:**

Section 1. The following Budget Line Items shall be increased by the amounts stated herein:


Fieldhouse Refunds	101.301.270.2	\$1,000.00
Harvest Home Refunds	101.302.270.2	\$2,500.00
Public Works-Fuel	101.506.221.1	\$2,000.00
Hillebrand Property Tax Refund	101.707.270.3	\$16,200.00
Tax Department Refunds	101.707.270.1	\$8,800.00

Section 2. The following Budget Line Items shall be decreased by the amounts stated herein:


Fieldhouse Salaries	101.301.211.1	\$1,000.00
Harvest Home Building Improvements	101.302.235.3	\$2,000.00
Harvest Home Equipment < 5 years	101.302.244.1	\$500.00
Public Works Salaries	101.506.211.1	\$2,000.00
Public Works Equipment > 5 years	101.506.252.1	\$25,000.00

Section 3. Line Item 101.707.270.3 entitled "Hillebrand Property Tax Refund" shall be added to the General Fund Account.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.


