## CITY OF CHEVIOT STATE OF OHIO

ORDINANCE NO. 22-

TO AMEND THE FEES FOR THE USE OF THE CITY FACILITIES; AND TO DECLARE AN EMERGENCY.

WHEREAS, the rental rates for the usage of the city facilities at Harvest Home Park and the Cheviot Memorial Fieldhouse were amended by Ordinance 22-01; and

**WHEREAS**, Council would like to amend the rental rates schedule to include rates for usage of City parking lots; and

WHEREAS, Council would like to clarify use of City facilities by certain groups at a reduced charge.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

<u>Section 1.</u> The City Parking Lots shall be identified as follows, and shall be rented in 5-hour increments, with an additional hour for setup:

- The Parking Lot on Harrison Ave, behind Pioneer Park will be identified as Parking Lot #1
- The Parking Lot on North Bend Road, close to Harrison Ave will be identified as Parking Lot #2
- The Parking Lot on Glenmore and Gamble will be identified as Parking Lot #3
- The Parking Lot on Robb Ave @ the Fieldhouse will be identified as Parking Lot #4
- The Parking Lot at Harvest Home Park will be identified as Lot #5

<u>Section 2.</u> There is hereby approved a new rate schedule for the usage of the city facilities at Harvest Home Park and Cheviot Fieldhouse. A copy of the new rate schedule is attached hereto and incorporated herein as Exhibit "A." The new rates shall be effective for all new contracts issued by the Recreation Commission. Existing contracts shall continue at the rate in effect at the time of the contract.

<u>Section 3</u>. The following groups are approved for reduced rates, as set forth in the rate schedule: Harvest Home Fair Committee, Cheviot Eagles "Honor Run," Purple Heart, VFW, American Legion.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to maximize the use and revenue of its municipal facilities.
