CITY OF CHEVIOT STATE OF OHIO

ORDINANCE NO. 23-11

TO AMEND THE 2023 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to meet certain expenses, it has become necessary to make adjustments to the appropriations of the 2023 annual budget by increasing and decreasing certain budget line items and adjusting the budget appropriations through transfers.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

<u>Section 1.</u> The following budget line items shall be increased as follows:

Section 2. The following budget line item shall be decreased as follows:

<u>Section 5.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
