RESOLUTION NO. 14 – 22

TO ACCEPT THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION; TO AUTHORIZE THE NECESSARY TAX LEVIES; TO CERTIFY THEM TO THE COUNTY AUDITOR; AND TO DECLARE AN EMERGENCY.

WHEREAS, the Council of the City Cheviot, Hamilton County, Ohio, met in regular session on the 7th day of October, 2014, at Cheviot City Hall, with the following members present:

WHEREAS, Dennis Dinkelacker moved for the adoption of this resolution; and

WHEREAS, on July 15, 2014, by Resolution No. 14-14, this council, in accordance with the provisions of law, has adopted a tax budget for the next succeeding fiscal year commencing January 1, 2015; and

WHEREAS, the Budget Commission of Hamilton County, Ohio, has certified its action thereon to this council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this council and what part thereof is without, and what part is within, the ten mill limitation;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The amounts and rates, as determined by the Budget Commission in its certification are hereby accepted.

Section 2. There is hereby levied on the tax duplicate of the City of Cheviot rate of each tax necessary to be levied within and without the ten mill limitation in accordance with the following Schedule A and Schedule B:

Section 3. Upon the passage of this resolution, the Clerk of Council shall certify a copy of it to the Auditor of Hamilton County.

Section 4. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to meet all deadlines set by the Hamilton County Budget Commission.
