RESOLUTION NO. 14 – 27

TO APPROVE THE TERMS OF THE GREEN TOWNSHIP/CITY OF CHEVIOT JOINT ECONOMIC DEVELOPMENT DISTRICT IV EARNINGS TAX PROVISIONS; TO APPOINT THE SAFETY-SERVICE DIRECTOR TO THE BOARD OF DIRECTORS FOR THE JOINT ECONOMIC DEVELOPMENT DISTRICT; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City of Cheviot and Green Township have previously agreed to enter into a Joint Economic Development District for certain property on Harrison Avenue in Green Township, now known as "JEDD IV"; and

WHEREAS, in order to properly administer the collection of taxes from JEDD IV, it is necessary to establish earnings tax provisions authorized by the JEDD agreement and agreeable to both the City of Cheviot and Green Township; and

WHEREAS, it is also necessary to appoint a representative of the City of Cheviot to the JEDD IV Board of Directors; and

WHEREAS, the City of Cheviot desires to appoint its Safety-Service Director to the Board;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1</u>. The Green Township B City of Cheviot Joint Economic Development District IV Earnings Tax Provisions, which are attached hereto and made a part hereof, are hereby approved.

<u>Section 2</u>. The Safety-Service Director of the City of Cheviot is hereby appointed to be the representative of the City of Cheviot on the Board of Directors of the Green Township B City of Cheviot Joint Economic Development District IV.

<u>Section 3</u>. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the Green Township B City of Cheviot Joint Economic Development District IV to be
