
**WHEREAS**, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor of funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local political subdivision;

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**


Section 1. The Auditor and Treasurer of Hamilton County, in accordance with Section 321.34 of the Ohio Revised Code, are requested to draw and pay to the City of Cheviot, upon the written request of Theresa Ciolino-Klein, Auditor, and Joseph L. Pahls, Treasurer, to the County Auditor, funds due in any settlement of 2017 derived from taxes or other sources, payable to the County Treasurer to the account of the City of Cheviot, and lawfully applicable for purposes of the current fiscal year.

Section 2. Upon passage of this Resolution, the Clerk of Council shall immediately forward a certified copy of it to the Hamilton County Auditor.


Section 3. This Resolution shall take effect immediately.






