RESOLUTION NO. 17 - 05

**TO AUTHORIZE THE ECONOMIC DEVELOPMENT DIRECTOR TO FILE AN APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES FOR A "NATUREWORKS" GRANT; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, the State of Ohio, through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes through the State of Ohio NatureWorks grant program; and

**WHEREAS**, the City of Cheviot desires financial assistance under the NatureWorks grant program;

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**

Section 1. The City of Cheviot approves filing the application for financial assistance.

Section 2. Caroline Statkus, the City Economic Development Director, is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

Section 3. The City of Cheviot agrees to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the NatureWorks grant program.

Section 4. Upon passage of this resolution, the Clerk of Council shall certify a copy of it to the City Economic Development Director, who is charged with informing the Ohio Department of Natural Resources of council's action.


Section 5. This resolution shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the city to apply for a NatureWorks grant at the earliest possible time.






