RESOLUTION NO. 17 - 10

TO APPROVE AN UPDATE TO THE SOLID WASTE MANAGEMENT PLAN OF THE HAMILTON COUNTY SOLID WASTE MANAGEMENT DISTRICT.

WHEREAS, pursuant to the provisions of Chapter 373 of the Ohio Revised Code (the "Act"), the Hamilton County Solid Waste Management District Policy Committee (the "Policy Committee") has adopted an update of the solid waste management plan (the "Plan Update") for the Hamilton County Solid Waste Management District (the "District"); and

WHEREAS, pursuant to the Act, the Board of County Commissioners in the District, and the legislative authority of each municipal corporation or township under the jurisdiction of the District must approve or disapprove of the Plan Update by ordinance or resolution; and

WHEREAS, the City of Cheviot has reviewed the Plan update and has determined that the Plan Update is in the best interest of the City of Cheviot and Hamilton County;

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, THAT:

Section 1. Approval of the Plan Update. This Council hereby approves the Hamilton County Plan Update, which is incorporated by reference into this resolution as if fully set out herein.


Section 2. Compliance with Open Meetings Law. It is hereby certified that all formal actions of the council of the City of Cheviot relating to the adoption of this resolution were taken in an open meeting of the council of the City of Cheviot, and all deliberations of the council of the City of Cheviot were in meetings open the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. Forwarding of Resolution. Upon passage of this resolution, the Clerk of Council shall deliver a certified copy of it to the Hamilton County Solid Waste Management District.

Section 4. Effective Date. This resolution shall become effective immediately upon passage.


