RESOLUTION NO. 17-20

TO ACCEPT THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION; TO AUTHORIZE THE NECESSARY TAX LEVIES; TO CERTIFY THEM TO THE COUNTY AUDITOR; AND TO DECLARE AND EMERGENCY.

WHEREAS, the Council of the City of Cheviot met in regular session on the 17th day of October, 2017, at the Cheviot City Hall with the following members present:

WHEREAS, on July 18, 2017, by Resolution 17-11, this council adopted a tax budget for the next succeeding fiscal year commencing January 1, 2018; and

WHEREAS, the Budget Commission of Hamilton County, Ohio, has certified its action thereon to this council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this council, and what part thereof is without, and what part is within the ten-mill limitation;

Now, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. The amounts and rates, as determined by the Budget Commission in its certification, are hereby approved and accepted.

Section 2. There is hereby levied on the tax duplicate of the City of Cheviot the rate of each tax necessary to be levied within and without the ten-mill limitation as specified in the following Schedule A and Schedule B:



Section 3. Upon passage, the Clerk of Council shall cause a copy of this resolution to be certified to the Hamilton County Auditor.


