RESOLUTION NO. 20-01

**TO APPROVE THE RE-INSTITUTION OF THE CHEVIOT COMMUNITY UNOFFICIAL JUVENILE COURT.**

**WHEREAS**, by Resolution 97-14, this Council approved the City's participation in the Unofficial Juvenile Court Volunteer Referee Program, as created by the Hamilton County Juvenile Court; and

**WHEREAS**, said program has been successful in Cheviot in diverting many young persons from the official Court process, but the program has become inactive in recent years; and

**WHEREAS**, the county-wide program has evolved and the Hamilton County Juvenile Court now seeks to appoint volunteers from the community to act as unofficial hearing officers in the community unofficial courts; and

**WHEREAS**, Law Director Kimberlee Erdman Rohr was willing to offer her services in the position as unofficial hearing officer, which position is a volunteer position without compensation by the Juvenile Court, and the Juvenile Court has appointed the Law Director as unofficial hearing officer for the Cheviot Community Unofficial Court; and

**WHEREAS**, this Council agrees that the Community Unofficial Court is a worthwhile program for the City to be proactive with the juvenile population of the City.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:**


Section 1. The Council hereby affirms the benefit of the Cheviot Community Unofficial Juvenile Court, and hereby approves the re-institution of the Community Unofficial Juvenile Court in Cheviot.

Section 2. This Council recognizes that Law Director Kimberlee Erdman Rohr was appointed by the Juvenile Court as unofficial hearing officer for the Cheviot Community Unofficial Court.

Section 3. This Council authorizes the use of the Cheviot City Hall facility for the conduct of the court, so long as the use does not conflict with council meetings, mayor's court, county court, or another previously scheduled use of the facility.
