RESOLUTION NO. 22-09

TO DECLARE JUNE 2022 "PRIDE MONTH" IN THE CITY OF CHEVIOT.

WHEREAS, the City of Cheviot, Ohio is home to a diverse and inclusive community; and

WHEREAS, individuals who are lesbian, gay, bisexual, transgender, and queer (LGBTQ+) include individuals from all faiths, races, national origins, socioeconomic statuses, education levels, political beliefs, and other intersectional identities; and

WHEREAS, LGBTQ+ people in the United States have made, and continue to make vital contributions to the United States and to the world in every aspect, including in the fields of education, law, health, business, science, research, economic development, architecture, law enforcement, healthcare, fashion, sports, government, military, music, film, politics, technology, literature, and civil rights; and

WHEREAS, on June 26, 2015, the Supreme Court of the United States ruled in Obergefell v. Hodges, 135 S. Ct. 2584, that same-sex couples have a constitutional right to marry and acknowledged that "[n]o union is more profound than marriage, for it embodies the highest ideals of love, fidelity, devotion, sacrifice, and family."; and


WHEREAS, LGBTQ+ people in the United States have fought for equal treatment, dignity, and respect; and
