Re: Police Department Activity Report

During the 2nd quarter of 2019, The Cheviot Police Department activity included:

Our department received 1309 calls for service in the 2nd quarter from the Hamilton County Communications Center. Not included in that number were 638 self / non billed details for a total of 1947 responses for service. Officers made a total of 3531 entries, for the second quarter, into our Pamet reporting system. These additional entries represent extra assignments, building checks, vacation checks, business checks, directed patrol, warrant service etc.

Correspondence(s) and Commendations:

As presented to Council, Sgt. Patton and his K9 partner Kuno received a commendation for their assistance in Springfield Twp. Springfield Twp officers requested a K9 unit to their location during a traffic stop investigation. K9 Kuno alerted on a package found to contain 1 ½ lbs of cocaine.

On June 28, 2019 approx. 0800 hrs officers responded to a burglary report on Puhlman Av. Besides items taken from the residence, a vehicle was stolen out of the driveway. After collecting fingerprints, a match on file was obtained and the name of a possible perpetrator

identified. While patrolling the area of the suspects residence, Sgt. Patton identified a vehicle in a nearby parking lot as the stolen vehicle. An unmarked vehicle was placed at the lot to watch the stolen vehicle, as marked police vehicles remained out of sight in the area. After 1 hr of surveillance two individual were seen getting into the stolen vehicle. All units moved in to make the arrests. Within 5 hrs of the initial report, without incident, both parties were apprehended, and arrests made for RSP, Unauthorized Use and Burglary.
