Year-end Police Department Activity Report

During the calendar year of 2019, The Cheviot Police Department received 5301 calls for service from the Hamilton County Communications Center. Not included in that number were 2555 self-initiated/ non-billed details for a total of 7856 dispatcher related responses for service. Officers logged a total of 14986 entries for the year of 2019 into our Pamet reporting system. These additional entries represent extra jobs, building checks, vacation checks, business checks, self- initiated details, details called into the station, directed patrols etc. These entries represent those which are not dispatched from Hamilton County Communications.

Officer Commendations

PO Bittner received many commendations in 2019 regarding an incident which occurred in July 2019.

PO Reinshagen and PO Smith received a thankyou letter for their assistance during a loss of a family member in Feb of 2019.

PO Reinshagen and Sgt Dietrich received a note of thanks for recovering a set of license plates inadvertently left on a vehicle.

Sgt. Patton received a letter of thanks from the City of Reading Police Department for K9 assistance in a local school in October of 2019.

Sgt. Patton, Detective Goff and PO Reinshagen received a Letter of Commendation for the recovery of a vehicle and property taken from a home burglary. Two suspects were arrested for the crime within 5 hours of the report. This occurred in July of 2019.

PO Barlag received a Life Saving Award from the Cheviot Fire Dept. for pulling a woman out of a burning house as well as catching a male from the second-floor balcony as he had no other escape from the residence. This occurred in May 2019.

PO Climer received a Letter of Commendation from Sgt Dietrich after he was able to talk a suicidal subject out of harming themselves. They held a butcher knife to their arm and chest. The subject eventually relented the weapon and was transported on a 72-hour hold. This occurred in early in 2019.

Information of note

The Cheviot Police Department have received and are utilizing protective heavy vests and helmets purchased under a Grant in 2018.

Two cruisers were ordered from Ford in April of 2019. We have received a half dozen or more promises for build dates, none of which have come to fruition. The most recent being Feb of 2020 with no confirmation yet.

Our RMS (Pamet) is currently up and running. Gains have been made to secure most of our reporting information however several months are still lost. Recently Pamet has announced their RMS service will reach end of life in Dec of 2021. Upgrades and support will begin to cease in Dec of 2020. We are currently seeking a replacement RMS at this time and are awaiting compatibility test results due to be released in March of 2020.

Cheviot officers logged 648 hrs of training for the 2019 calendar year.

Beginning on Nov 21, 2018 our Police Department was issued Narcan. This was issued to officers so they or their partners may administer it in the event an officer becomes overtaken by the effects of an opiate/fentanyl. Additionally, officers may administer the drug to overdose victims if that may be done so in a safe environment for all concerned. Officers have administered Narcan 11 times in the calendar year of 2019.
