

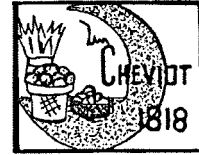

Re: Police Department Activity Report

During the 1st quarter of 2020, The Cheviot Police Department activity included but not limited to the following:

Our department received 1296 calls for service in the 1st quarter from the Hamilton County Communications Center. Not included in that number were 519 self/ non billed details for a total of 1815 responses for service. Officers made a total of 4313 entries, for the first quarter, into our Pamet reporting system. These additional entries represent extra jobs, building checks, vacation checks, business checks, directed patrol etc. Note: It appears blotter entries for the first quarter of 2020 appear to be up 19% during the same period last year.

**Training:**

Many of our officers scheduled training has been canceled due to Coronavirus concerns. It is unclear when or if those trainings will be rescheduled.

Officers are still utilizing online training as practiced in the past.

**Note:**

During the First Quarter PO Smith retired from his position as a police officer with the City of Cheviot Police Department.

We are currently accepting applications for a full-time eligibility test. The test has been postponed and rescheduled for July 25, 2020.

We have hired two new part-time officers who are working going through our FTO training at this time.

We have recently signed a contract with Sundance Systems Inc. Soon we will be uploading and training on our new Report Management System. It is our hopes to incorporate our existing Pamet information into this new system.

After one year since ordering, we have received our 2 cruisers. Both are now in service.
