Introduced by Mr. Sunderhaus, seconded by Mr. Clark and carried with a 7-0 vote.

Ordinance 12-10 To Grant An Easement To The Metropolitan Sewer District; And To Declare An Emergency. Introduced by Mr. Sunderhaus, seconded by Mr. Dinkelacker. Motion to suspend the rules made by Ms. Zech, seconded by Mr. Baker. Motion to adopt made by Mr. Dinkelacker, seconded by Mr. Clark. Carried with a 7-0 vote.

Ordinance 12-11 To Amend The 2012 Annual Budget Appropriations; And To Declare An Emergency. Introduced by Mr. Sunderhaus, seconded by Mr. Baker. Motion to suspend the rules made by Mr. Sunderhaus, seconded by Mr. Zech, Motion to adopt Ordinance 12-11 carried with a 7-0 vote.

There were no reports from the Mayor, Law Director, Safety Service Director.
