Safety Service Director: CWW will do a water main project on Herbert Ave. Mr. Waters to draw up a Memorandum of Understanding with Cheviot Savings Bank prior to beginning work on the municipal parking lot.

Law Director: Working on ordinance to amend the commercial solicitation ordinance, and an ordinance to ban texting and driving in the City of Cheviot. Also discussed Judge Winkler's decision does not apply to Cheviot as a statutory city. Still a federal lawsuit pending with regard to rental properties.

Public Recognition: Dee Bardes of Hyde Park was in the meeting and addressed council on her concerns about the state of some of the headstones in the cemetery.
