Third reading of Ordinance 13-14 TO APPROVE THE CREATION OF A JOINT ECONOMIC DEVELOPMENT DISTRICT WITH COLERAIN TOWNSHIP, OHIO, TO BE KNOWN AS THE "LIBERTY NURSING HEALTH CARE" JOINT ECONOMIC DEVELOPMENT DISTRICT.
