He also reported that any property owner that had been overcharged the parhage fee will receive a credit on their next statement. This affected owners of multi-family buildings only.

Law Director: Mr. Waters had no report, except that the recent Supreme Court ruling has declared that opening a meeting with prayer is now within the law.

Treasurer's Report: Needing further revision, the report has been deferred to the May 20th meeting.
