Motion to introduce by Mr. Martin, second by Mrs. Richter. Motion to suspend the rules by Mr. Sunderhaus, second by Mr. Martin. Motion to adopt by Mrs. Richter, second by Mr. Clark. Passed by unanimous vote.


Ordinance 15-28 To Approve An Extension Of The City's Contract With Rumpke, Inc.; To Authorize The Safety-Service Director To Sign The Extension On Behalf Of The City; And To Declare An Emergency. Motion to introduce by Mr. Sunderhaus, second by Mrs. Richter; Motion to suspend the rules by Mrs. Richter, second by Mrs. Clark; Motion to adopt by Mr. Sunderhaus, second by Mr. Martin. Passed by unanimous vote.


