Mayor's Report: Mayor Keller had no formal report.

Safety Services Director: Mr. Braun reported that to date, 74 pool passes have been sold. There will be a pre-construction meeting on the Ruth-Ruckle-Roswell resurfacing project held on June 20. Westwood-Northern Boulevard will go out for bid at the end of June. Courtroom lease agreement is up for renewal (new legislation is required to extend the existing agreement).

Law Director: Mrs. Slaughter stated that there will be no council meeting held on the first Tuesday of July because it is the 4th of July holiday. Also, council will take their summer recess the first week of August, so during the months of July and August, there will be meetings held on the third Tuesdays only. Plan accordingly.

There was one property maintenance violation.

The Streets and Sidewalks Committee will reconvene on June 20 at 6:30PM prior to the council meeting to discuss the building permit rates.
