Ordinance 17-11 To Amend Section 155.01 Of The Codified Ordinances Of Cheviot. Motion to present for second reading made by Mrs. Zech, second by Mr Dinkelacker, followed by unanimous voice vote.

Ordinance 17-16 To Approve A New Lease Agreement With Hamilton County, Ohio For Its Use Of The Cheviot Municipal Building For Area Court; And To Declare An Emergency. Introduced by Mr. Martin, second by Mrs. Tucker. Motion to suspend the rules made by Mr. Sunderhaus, second by Mrs. Zech. Motion to adopt made by Mr. Dinkelacker, second by Mrs. Tucker. All motions carried unanimously.

Ordinance 17-17 To Increase The Building Permit Fees For Sidewalk Repairs To \$20.00; And To Declare An Emergency. Motion to introduce made by Mr. Sunderhaus, second by Mrs. Zech. Motion carried 7-0. Motion to suspend the rules made by Mr. Sunderhaus, second by Mr. Martin. Motion carried 7-0. Motion to adopt made by Mr. Dinkelacker, second by Mr. Sunderhaus. Motion carried with 5-2 with Mrs. Tucker and Mrs. Richter being the two nay votes.

Law Director: Mrs. Slaughter stated that there will be no council meeting held on the first Tuesday of July because it is the 4<sup>th</sup> of July holiday. We will be voting on the budget at the July 18 meeting. All litigation has been settled. The Workers Comp trial is scheduled for September.

Public Recognition: Mr. and Mrs. Dave Harmeyer were present to discuss the permitting process for sidewalk repair. Ms. Claire Hubble wanted to discuss the crumbling pavement of the pathway between Roswell & Kenkel. Both parties were advised to contact Mr. Braun.


