Resolution 19-04 To Approve The City Of Cheviot Police Department's Written Internal Control Policy For Drug Offender Fines Fund. Introduced by Mr. Sunderhaus, second by Mr. Voss. Adopted by unanimous vote.

Resolution 19-05 To Approve The City Of Cheviot Police Department's Written Internal Control Policy for Criminal Activity Forfeiture Fund. Introduced By Mr. Sunderhaus, second by Ms. Griffin. Lacking a majority of yes votes, this resolution will be sent back to committee for further discussion.

Ordinance 19-03 To Amend Sections 131.05 and 131.06 Of The Cheviot Code Of Ordinances To Revise The Notice Procedures. Motion to introduce made by Mrs. Zech, second by Mrs. Tucker. This constitutes the first of three readings required for passage.

In the midst of the presentation of the aforementioned legislation, Mayor Keller turned over the meeting to Fire Chief Klein for the purpose of introducing Dr. Morris, who serves as our Medical Director, a position he has served at no cost to the City. We acknowledge and thank Dr. Morris for his dedication and service.

Mayor's Report: Mayor Keller thanked everyone involved in negotiating the FOP contract.

Safety Services Director: Mr. Braun asked if council wants to make any changes to the pool fees. Siebel's clarified their request to purchase an area near their building for better access for deliveries.

Law Director's Report: Mrs. Rohr will call the liquor commission to see how Family Dollar's appeal is progressing.

Mrs. Slaughter's Family Day planning will begin in March. Kerry Smyth has agreed to co-chair the event.
