Mayor's Report: There will be a Harvest Home Fair volunteer appreciation gathering held at Harvest Home Park on October 15 at 7PM. All city officials have been invited, but since we'll be having our regular meeting that night, Mayor Keller encourages all to stop by after the meeting. The city picnic is this Friday. Please let Sarah know if you're coming to insure that there is enough food and refreshments for everyone. City administration will be volunteering at Ronald McDonald house tomorrow (Oct. 2).

Safety Service Director: Trevor Ave is in the punch list stage. Work on city hall to repair drainage issues are underway. Davis, Delmar, Olivette, Alma project has been filed with OPWC. We should find out in November about funding for these projects. Bruestle to start 10/2. Drain repair in front to city hall is underway. Rumpke was submitted a new proposal. The current contract expires 12/31/19. Over the next three years they are proposing incremental dump rate increases. There was some discussion about whether dumping needs to go out to public bid, at which time Rumpke may rescind their proposal and rebid at a higher rate. Mr. Waters called for a vote to see if council would like a legal opinion from Mrs. Rohr. The vote ended in a tie. He then asked Mrs. Rohr for an opinion, which she said she could prepare by the end of October.

Law Director: No news on the Family Dollar appeal for the liquor license. The Unofficial Juvenile Court will be held at Cheviot School. Mrs. Rohr received a letter from the Hamilton County Juvenile Court stating that the volunteer presiding over the unofficial juvenile court has no adjudication powers, and that her serving in this capacity is not a conflict. Anyone can serve in this capacity. Mrs. Rohr will report back to council in answer to all their questions once she has received all of the information needed.

Public Recognition on Non-Agenda Items: Mrs. Slaughter requested a full copy of the annexation legislation as she had not received on via email. Mr. Waters gave her a copy. She still questioned why Mrs. Rohr's appointment to Unofficial Juvenile Court was not brought before council. Mr. Waters questioned whether there is an ordinance in place dealing with this.

Other Business: Mayors Court receipts for August were received and filed with a motion by Mrs. Hardig and a second by Ms. Griffin. Joe Pahls had submitted his quarterly credit card report as well as the treasurer's report for July, 2019. The credit card report was received and filed with a motion by Mrs. Zech, second by Mr. Voss. The July treasurer's report was received and filed with a motion by Mrs Zech and a second by Mrs. Hardig.

Upcoming Meetings: Mrs. Tucker's SST Committee meeting originally scheduled for October 15 will be rescheduled. Time and date to be determined.
