Committee Reports: Laws, Rules & Ordinances committee met on August 25 for futther discussion of the creation of a DORA (Designated Outdoor Refreshment Area). Mrs. Zech's report is on file with the clerk and viewable on the City's website. The report was received and filed with a motion from Mrs. Zech, a second from Mr. Sunderhaus and a unanimous council voice vote.

Mrs. Zech motioned to receive and file the DORA application. Her motion was seconded by Mr. Cunningham, and it carried with a 6-1 voice vote, with Mrs. Richter abstaining.

A motion was then made by Ms. Griffin to direct the Clerk to publish a notice stating the acceptance of the DORA and announcing the date of the public hearing in a newspaper of general circulation in accordance with R.C. 4301.82(c). Mrs. Hardig seconded the motion, and it carried unanimously. The public hearing will be held in council chambers on Tuesday, September 22 at 7PM. A special council meeting will follow for the purpose of adopting the Ordinance to approve the DORA.

Department Reports: Treasurer Joe Pahls submitted a corrected credit card report as well as monthly treasurer's reports from April and May 2020. The Treasurer's report was received and filed with a motion by Mr. Voss, second by Mrs. Hardig.
