Administrative Reports:

- --Mayor Keller stated that no changes have been made to protocols as a result of new Covid cases being on the rise. This could change, and he will keep all of council updated. The City has adopted a new insurance carrier and has negotiated a 15 month contract so that coverage follows the calendar year. The contract is up for renewal December 31, 2022. No news has been received from last's year's census. Mr. Voss asked about our contract with National Inspections. Mayor Keller stated that it is a two-year contract with auto-renewal, unless either party withdraws.
- --Law Director Rohr advised that outside counsel continues work on the Hillebrand taxation issue.

- -- Ms. Hawk read her report from the received LSDMC meeting

- --Mrs. Zech called a meeting of the Laws, Rules & Ordinances Committee (Tuesday, September 7, 6:30PM) to discuss the DORA and whether or not to keep it. Also, discuss extending it to include the area by R&R Meats; and to authorize the Safety Services Director to extend the hours of the DORA for special occasions.
- --Mr. Cunningham what the plans are for the former Frank's lot. Grading/staking has begun for a convenience store/fuel center with restaurant capabilities.
