The special session of Council was called to order at 7:06 P.M. with the Pledge of Allegiance and a moment of prayer. Roll call was taken and the following were found in attendance:

Mrs. Zech made a motion to excuse Mr. Babey with a second from Mr. Braun. The motion passed 6-0 by roll call vote. President McKinney dispensed with normal proceedings.

Mr. Zech made a motion to introduce an ordinance *To Set The Rates For Swimming Lessons For The 2008 Season; And To Declare An Emergency* with a second from Mr. Dinkelacker. The motion carried 6-0 by voice vote and was assigned as ORD 08-15. Mr. Sunderhaus made a motion to suspend the rules with a second from Mr. Stautberg. The motion carried 6-0 by roll call vote. Mr. Zech made a motion to adopt with a second from Mr. Stautberg. The motion carried 6-0 by roll call vote. Mr. Zech made a motion to introduce an ordinance *To Select An Insurance Company For Liability Coverage In 2008 And 2009; And To Declare An Emergency* with a second from Mr. Sunderhaus. The motion carried 6-0 by voice vote and was assigned as ORD 08-16. Mr. Dinkelacker made a motion to suspend the rules with a second from Mr. Sunderhaus. The motion carried 5-0-1 by roll call vote with Mr. Zech abstaining due to his employment with Cincinnati Insurance. There was much discussion. Mr. Dinkelacker made a motion to adopt with a second from Mrs. Zech. The motion carried 5-0-1 by roll call vote with Mr. Zech abstaining due to his employment with Cincinnati Insurance. Mr. Braun made a motion to introduce an ordinance *To Grant A License To Keller Family Adventures, LLC, For The Use Of Airspace Over A Portion Of The City's Municipal Parking Lot #1; And To Declare An Emergency* with a second from Mr. Sunderhaus. The motion carried 6-0 by voice vote and was assigned as ORD 08-17. There was much discussion. This constituted the first reading of ORD 08-17. President McKinney scheduled the second reading of ORD 08-17 for Wednesday, May 28<sup>th</sup> at 8:30 P.M.

Mr. Stautberg informed Council that the Police Dog Line Item has been set up in the City's Budget. President McKinney announced that there would be no Council meeting on July 15<sup>th</sup>.

There was a motion to adjourn the meeting by Mrs. Zech with a second from Mr. Zech. The motion passed 6-0 by voice vote. The meeting adjourned at 7:31 P.M.
