The special session of Council was called to order at 6:20 P.M. with the Pledge of Allegiance and a moment of prayer. Roll call was taken and the following were found in attendance:

Mr. Stautberg made a motion *To Authorize All Actions Necessary To Create A Governmental Natural Gas Aggregation Program With Opt-Out Provisions Pursuant To Section 4929.26 Of The Ohio Revised Code; To Direct The Hamilton County Board Of Elections To Submit A Ballot Question To The Electors; And To Declare An Emergency with a second from Mr. Sunderhaus. There was some discussion before the motion carried 7-0 by voice vote and was assigned as ORD 06-23. Mr. Zech made a motion to suspend the rules with a second from Mr. Dinkelacker. The motion carried 7-0 by roll call vote. Mr. Norman made a motion to adopt with a second from Mr. Zech. The motion carried 7-0 by roll call vote. Mr. Stautberg thanked everyone for coming together so quickly to pass this issue, as it should save Cheviot residents money on their energy bills.*

After some discussion on the ordinance, Mr. Sunderhaus made a motion *To Temporarily Permit The Cheviot-Westwood Kiwanis Club To Erect A Banner Over North Bend Road; And To Declare An Emergency* with a second from Mr. Stautberg. The motion carried 7-0 by voice vote and was assigned as ORD 06-24. Mr. Sunderhaus made a motion to suspend the rules with a second from Mr. Braun. The motion carried 7-0 by roll call vote. Mr. Dinkelacker made a motion to adopt with a second from Mr. Sunderhaus. The motion carried 7-0 by roll call vote.

President Pro-Tem Zech gave the 5th reading of the proposed Sign Ordinance. She then informed Council that the Law Director has promised her the Sign Ordinance will be finished by the next regular meeting of Council, and that she will call a Public Hearing on the issue at that time.

There was a motion to adjourn the meeting by Mr. Zech with a second from Mr. Braun. The motion passed 7-0 by voice vote. The meeting adjourned at 6:32 P.M.
