MINUTES OF CITY COUNCIL MEETING, CHEVIOT, OHIO

Page 1 of 2 September 21, 2004

The regular session of Council was called to order at 7:31 P.M. with the Pledge of Allegiance and a moment of prayer. Roll call was taken and the following were found in attendance:

Mr. Mestemaker made a motion to excuse Mrs. Zech and Mr. Dinkelacker with a second from Mrs. Gooch. The motion carried 5-0 by voice vote. The minutes of September 9, 2004 were approved. President Morganroth pointed out an error made in the August 17th minutes that he noticed after the minutes were approved; the time that the meeting adjourned was corrected. President Morganroth called for the reports that would be presented.

Richard Gableman, Legal Council for Vincent Rack of the V & G Rack Company, addressed council looking for a reduction in the bonds that the City of Cheviot requires for him to bring heavy equipment down Bruestle Avenue. According to Mr. Gableman, the bond was one million dollars in 1988. Mr. Waters suggested that he speak with Mr. Mestemaker about this in the Streets, Sidewalks, and Lights committee. This issue was placed in the Streets, Sidewalks and Lights committee for further investigation.

Mayor's Report

Mayor Keller passed on his thanks to the Cheviot Police, Fire, and Public Works Departments for their hard work during the Harvest Home Fair and Parade. He thanked Chief Voss, Chief Clark, Tom Braun, Steve Neal and others for their hard work. Mayor Keller reported that he met with Mr. Neal, the building commissioner Charlie Meyer, and Principal Bonnevita of Cheviot school to discuss various easement issues. Mayor Keller also mentioned the addition of a Community Board posted in front of Cheviot School with school news, construction updates and other things pertaining to the immediate area. Mayor Keller then took a moment to explain to the public that the Cheviot tax levy will be Issue 2 on the November ballot along with dozens of other levies. Mayor Keller reminded the public to remember Cheviot when voting and that there will be 3 public hearings pertaining to the Tax Levy in the coming future.

Law Director's Report

Mr. Waters reported that the Liquor Control Board has set the hearing for the liquor license for Stewart's Irish Pub on October 8, 2004 at 1:00 P.M. at Cincinnati City Hall.

The motion passed 5-0 by voice vote and was assigned ORD04-23. This concluded the first reading of ORD04-23.

He reported that he was going to do some more research into the bond amounts before calling a meeting of the Streets, Sidewalks and Lights Committee. Mr. Mestemaker made a motion *To Appoint A Chief Executive Officer, A Chief Financial Officer, And A Project Manager; To Submit The Necessary Application For The State Capital Improvement Program; To Execute A Project Agreement For The 2005 Program Year; And To Declare An Emergency.* Mr. Norman made the second. The motion carried 5-0 by voice vote and was assigned as RES04-19.
- Council at Large Mrs. Zech did not forward a report. Mr. Norman said that she had asked him to call a meeting of the Laws, Rules and Ordinances Committee for Wednesday, September 29 at 7:00 P.M. at Cheviot City Hall to discuss Zoning and Building Codes.
