Finally Mr. Neal reported that former Police-Explorer turned part-time Cheviot Police Officer Andy Happ who is currently serving in Iraq, recently received Sergeant Rank in the United States Army.

Mayor's Report

Mayor Laumann thanked Mr. Neal and the Cheviot Maintenance Department for setting up the Cheviot Nativity Scene. Mayor Laumann had also received several calls about the homicide and he wants citizens to know that the system does work. He reminds the residents that this type of investigation takes time especially if it is done right. Mayor Laumann also mentioned that he believes that the citizens are tired of saying good-bye and that the farewell reception in his honor wasn't his idea. He did want to thank everyone for all the kind words of support and for sharing their stories and feelings.
