ORDINANCE NO. 19- $\underline{/}$

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO OBTAIN A LOAN AND PURCHASE A GARBAGE TRUCK; AND TO DECLARE AN EMERGENCY.

WHEREAS, the Safety-Service Director has determined that the City needs a new garbage truck, and has recommended the purchase of a garbage truck for the City, namely a 2020 International with a McNeilus body, through state purchasing; and

WHEREAS, the Safety-Service Director has recommended that the garbage truck purchase be financed via a loan, not to exceed \$185,000.00, at an interest rate not to exceed 4.00%, and at a term of no longer than four years; and

WHEREAS, this Council agrees with the Safety-Service Director's recommendation; and

WHEREAS, pursuant to Cheviot Code of Ordinances, Section 35.63, this purchase is not required to be competitively bid.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1.</u> The Safety-Service Director is hereby directed to apply for a loan for the purchase of a 2020 International with a McNeilus body through the state purchasing program with the following terms: the loan amount shall not exceed \$185,000.00; the interest rate shall not exceed 4.00%; and the loan term shall not exceed four years.

<u>Section 2.</u> Upon approval of the above-described loan, the Safety-Service Director is directed and authorized to complete the purchase of the 2020 International with a McNeilus body through the state purchasing program.

<u>Section 3.</u> The Safety-Service Director is hereby authorized to sign any necessary documents to obtain the loan and complete the purchase as described herein.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep allow the Safety-Service Director to apply for the loan and complete the purchase of the garbage truck at the earliest possible time.
