

**CITY OF CHEVIOT

**ORDINANCE NO. 19-\_\_\_\_\_**

**TO AMEND THE 2019 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, it has become necessary to make adjustments to the 2019 annual budget appropriations by increasing the appropriations for tax refunds; and

**WHEREAS**, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:**

Section 1. The following budget line item shall be increased by the amount indicated:

302.202.250.2	Energy Efficiency Interest	\$5,315.63
101.301.270.2	FIELDHOUSE REFUNDS	\$1,700.00
101.302.270.2	HARVEST HOME REFUNDS	\$4,000.00
502.305.234.1	POOL SALARIES	\$6,000.00

The increase to Line Item 502.305.234.1 will increase pool certificate of available resources by \$6,000.00.

Section 2. The following budget line item shall be decreased by the amount indicated:

302.202.252.1	Energy Efficiency Project cost	\$5,315.63
101.301.252.1	FH EQUIPMENT > 5YEARS	\$500.00
101.301.244.1	EQUIPMENT < 5 YEARS	\$500.00
101.301.235.3	FH BUILDING IMPROVEMENTS	\$700.00
101.714.212.2	WORKERS COMPENSATION	\$4,000.00

Section 3. The sum of \$85,000.00 shall be transferred from the General Fund (No. 101) to the Police and Fire Pension City Share (Fund 701).

Section 4. The sum of \$5,290.25 shall be transferred from the General Fund (No. 101) to the Energy Efficiency Fund (No. 302) for Energy Efficiency Payment.

Section 5. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
