**ORDINANCE NO. 20-23**

**TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO ENTER INTO A CONTRACT TO PURCHASE A 2020 FORD F-450 4X4 AMBULANCE; AND TO DECLARE AN EMERGENCY.**

**WHEREAS**, the Safety-Service Director and Fire Chief have determined that the City needs a new life squad for the City's Fire Department, and have recommended the purchase of a new life squad for the City, namely a 2020 Ford F-450 4x4 Ambulance, through Ohio Cooperative Purchasing Program; and

**WHEREAS**, 911 Fleet and Fire Equipment is an authorized dealer of the supplier Wheeled Coach Industries under the state's Cooperative Purchasing Program; and

**WHEREAS**, 911 Fleet and Fire Equipment has provided a quote to the City for the purchase of a 2020 Ford F-450 4x4 Ambulance at a total price of \$198,945.00; and

**WHEREAS**, 911 Fleet and Fire Equipment has indicated that there is only a limited number of this type of vehicle available for purchase, and it will only hold the quote open until September 26, 2020 before releasing for other municipalities to purchase; and

**WHEREAS**, the Safety-Service Director has recommended the purchase of the ambulance at the quoted price and pursuant to the terms of the Sales Agreement, which is attached hereto as Exhibit A and incorporated herein; and

**WHEREAS**, this Council agrees with the Safety-Service Director's recommendation; and

**WHEREAS**, pursuant to Cheviot Code of Ordinances, Section 35.63, this purchase is not required to be competitively bid.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**

Section 1. The Safety-Service Director is hereby authorized and directed to enter into a Sales Agreement with 911 Fleet and Fire Equipment for the purchase of a 2020 Ford F-450 4x4 Ambulance for a total price not to exceed \$198,945.00, a copy of which is attached hereto as Exhibit A and incorporated herein.

Section 2. The Safety-Service Director is hereby authorized to sign any necessary documents to complete the purchase as described herein.

Section 3. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to enter into the sales contract before the life squad is purchased by another municipality, as there is only a limited number of vehicles available and to allow the Safety-Service Director to complete the purchase at the earliest possible time.
