ORDINANCE NO. 22-01

TO AMEND THE FEES FOR THE USE OF THE CITY FACILITIES AT HARVEST HOME PARK AND THE CHEVIOT MEMORIAL FIELDHOUSE; AND TO DECLARE AN EMERGENCY.

WHEREAS, the last amendment to the schedule of rental rates for the usage of the city facilities at Harvest Home Park and the Cheviot Memorial Fieldhouse was in 2014; and

WHEREAS, Council has conducted research regarding the cost to maintain, operate, and staff these facilities, as well as compared the City's rental rates with the rates of neighboring jurisdictions; and

WHEREAS, Council has determined that certain increases to the schedule of rental rates is necessary.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

Section 1. There is hereby approved a new rate schedule for the usage of the city facilities at Harvest Home Park and Cheviot Fieldhouse. A copy of the new rate schedule is attached hereto and incorporated herein as Exhibit "A." The new rates shall be effective for all new contracts issued by the Recreation Commission. Existing contracts shall continue at the rate in effect at the time of the contract.

Section 2. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to maximize the use and revenue of its municipal facilities.
