ORDINANCE NO. 22-09

TO ACCEPT THE RECOMMENDATION OF THE TAX INCENTIVE REVIEW COUNCIL REGARDING THE COMMUNITY REINVESTMENT AREA AGREEMENT FOR THE FAMILY DOLLAR STORE; TO TERMINATE THE COMMUNITY REINVESTMENT AREA AGREEMENT; AND TO DECLARE AN EMERGENCY.

WHEREAS, on March 19, 2013, by Resolution 13-15, this Council authorized a Community Reinvestment Area agreement with the Family Dollar Store; and

WHEREAS, on March 2, 2022, the Tax Increment Review Council met to review the Community Reinvestment Area Agreement with the Family Dollar Store; and

WHEREAS, the Tax Incentive Review Council determined the Community Reinvestment Area Agreement with the Family Dollar Store expired on December 31, 2021; and

WHEREAS, the Tax Incentive Review Council has recommended that the Community Reinvestment Area agreement with the Family Dollar Store be terminated effective December 31, 2021; and

WHEREAS, this Council finds that the recommendation of the Tax Incentive Review Council to terminate the Community Reinvestment Area agreement is in the best interest of the City of Cheviot.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS CONCURRING, THAT:

- Section 1. The recommendation of the Tax Incentive Review Council of the City of Cheviot to terminate the Community Reinvestment Area agreement with the Family Dollar Store effective December 31, 2021 is hereby approved.
- <u>Section 2.</u> This Council hereby terminates the Community Reinvestment Area agreement with the Family Dollar Store, which was authorized by Resolution 13-15, effective December 31, 2021.
- <u>Section 3.</u> This Council hereby authorizes the Mayor and other city officials to prepare and execute such other documents and do all other things as are necessary for and incidental to terminating the Community Reinvestment Area agreement.
- <u>Section 4.</u> This Council finds and declares that all formal actions concerning and relating to this Ordinance occurred in an open meeting of this Council or its committees, in compliance with law.
- <u>Section 5.</u> The report of the Tax Incentive Review Council of the City of Cheviot, a copy of which is attached hereto and made a part hereof, is hereby approved and accepted.

<u>Section 6.</u> Upon passage of this ordinance, the Clerk of Council shall certify a copy of it to the State of Ohio or to the official who is charged with informing the State of Ohio of this Council's action.

Section 7. This Ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to immediately notify the Family Dollar Store and restore the affected parcel to full taxation at the earliest period allowed by law, as well as to comply with the State's reporting deadline.

Summary of Tax Increment Review Council

- For Property Tax Year 2021
- Meeting held March 2, 2022 (Zoom)
- In attendance: Greg Jarvis (County Auditor's Office), Steve Brown, Ray Kroner, and Jennifer Wagner (CPS); staffed by Caroline Statkus

After review and discussion, the Tax Increment Review Council voted unanimously to recommend to Council that the CRA for Family Dollar be terminated as of Dec. 31, 2021, which is when it expired. The only action Council needs to take is to terminate the CRA to tie up loose ends for our report to the State. In 2022 Family Dollar owners will be subject to full property taxes.

Filing of Council's action on the CRA must be submitted to the Ohio Dept. of Development by March 31, 2022.

Each year the TIRC reviews Cheviot's CRAs (Community Reinvestment Areas) to assess if they still meet the original requirements under which they were established. The TIRC recommendations are forwarded to Cheviot City Council, who determine whether to continue, modify, or terminate the agreements.

Family Dollar, 3413 Harrison – CRA expires 2022 (note: 2021 is the last year of the tax abatement)

- Total employees = 4
- Total salaries = \$212,275
- Land Value = \$250,000
