ORDINANCE NO. 22

## TO AUTHORIZE PAY RAISES FOR CERTAIN FULL-TIME EMPLOYEES; AND TO DECLARE AN EMERGENCY.

WHEREAS, this Council has determined that salary increase is for certain City employees is necessary.

WHEREAS, the current salaries for said City employees are as follows:

Safety Service Director	\$ 107,899.22
Fire Chief	\$ 99,255.78
Police Chief	\$ 99,255.78
Office Manager	\$ 44,000.06
Tax Office Deputy	\$ 45,430.84
Tax Office Specialist	\$ 44,000.06
Asst. Auditor	\$ 45,430.84
Police/Court Clerk	\$ 45,430.84
Public Works Supervisor	\$ 84,531.20

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1.</u> Effective May 1, 2022, the Safety-Service Director, the Police Chief, the Fire Chief, the Public Works Superintendent, the Clerk of Courts, the Office Manager, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Specialist shall have their salaries increased by 6%. The salary increase is retroactive to the effective date herein.

<u>Section 2.</u> Effective January 1, 2023, the maximum amount of compensatory time that the above-described employees can maintain in their balance of compensatory time is 120 hours. Any compensatory time accrued through December 31, 2022 shall be retained, even if said time exceeds 120 hours; however, additional compensatory time above 120 hours shall not be retained if it was earned on January 1, 2023 or later.

<u>Section 3.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to fairly compensate the employees listed above at the earliest possible time.
