## **ORDINANCE NO. 23-12**

## TO AMEND ORDINANCE 23-11; AND TO DECLARE AN EMERGENCY.

**WHEREAS,** on April 18, 2023, this Council pass Ordinance 23-11, which amended the 2023 Annual Appropriations by increasing and decreasing certain line items; and

WHEREAS, there was a clerical error in the designation of certain line items, which needs to be corrected; and

WHEREAS, Ordinance 23-11 should be amended to reflect the correct line items.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

Section 1. Section No. 1 of Ordinance 23-11, passed on April 18, 2023, shall be amended to read:

<u>Section 1.</u> The following budget line items shall be increased as follows:

| Line Item     | Name           |           | Increase   |

Section 2. Section No. 2 of Ordinance 23-11, passed on April 18, 2023, shall be amended to read:

<u>Section 2.</u> The following budget line item shall be decreased as follows:

| Line Item     | Name                            | Decrease   |

| 709.111.251.2 | JEDD COL/LIB COLERAIN TWP SHARE | \$1,063.30 |
| 706.111.251.1 | JEDD II CHEVIOT SHARE           | \$465.12   |
| 706.111.251.2 | JEDD II GREEN TWP. SHARE        | \$1,860.46 |

Section 3. All other sections of Ordinance 23-11 shall remain as stated in the original ordinance.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to correct the clerical errors in Ordinance 23-11 and allow the City to meet its financial obligations in a timely manner.
