ORDINANCE NO. 23-13

TO AUTHORIZE THE ESTABLISHMENT OF HAMILTON COUNTY PUBLIC HEALTH GRANTS FUND (FUND NO. 240); TO AMEND THE 2023 ANNUAL BUDGET APPROPRIATIONS; AND TO DECLARE AN EMERGENCY.

WHEREAS, the City receives money from certain Hamilton County Public Health Grants; and this Council wishes to establish the Hamilton County Public Health Grants Fund (Fund 240) and line items (240.121.1 – Hamilton County Public Health Revenue and 240-101.239.3 – Hamilton County Public Health Contract Incidentals) for the incoming grant funds, revenues, and expenditures; and

WHEREAS, it has become necessary to make adjustments to the appropriations of the 2023 annual budget by increasing and decreasing certain budget line items.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. A new fund is hereby established for the revenues and expenditures associated with Hamilton County Public Health Grants, namely the receipt of grants and the expenditures pursuant to those grants, and said fund shall be identified as Hamilton County Public Health Grants Fund (Fund 240).

Section 2. The following line items are established:

240.121.1 – Hamilton County Public Health Revenue

240-101.239.3 – Hamilton County Public Health Contract Incidentals

Section 3. The following budget line item shall be increased as follows:

<u>Line Item</u>	<u>Name</u>	<u>Increase</u>
401.601.234.2	3 Mil Contract Incidentals A&T	\$7000.00

Section 4. The following budget line item shall be decreased as follows:

<u>Line Item</u>	<u>Name</u>	<u>Decrease</u>
401.601.234.1	3 Mill Contractual Services	\$7000.00

Section 5. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary as the City needs to request authorization from the State Auditor, and this ordinance is necessary in order to allow the City to meet its financial obligations in a timely manner.
