CITY OF CHEVIOT STATE OF OHIO

ORDINANCE NO. 23-14

TO AUTHORIZE PAY RAISES FOR CERTAIN FULL-TIME EMPLOYEES; AND TO DECLARE AN EMERGENCY.

WHEREAS, this Council has determined that it is necessary to increase the salaries for certain City employees within a range set by Council but at the discretion of the Administration.

WHEREAS, the current salaries for said City employees for 2023 are as follows:

Safety Service Director	\$114,373.17
Fire Chief	\$105,211.13
Police Chief	\$105,211.13
Tax Office Deputy	\$48,156.69
Tax Office Specialist	\$46,640.06
Asst. Auditor	\$48,156.69
Police/Court Clerk	\$48,156.69
Public Works Supervisor	\$89,603.07

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. Effective May 1, 2023, the Safety-Service Director, the Police Chief, the Fire Chief. the Public Works Superintendent, the Clerk of Courts, the Assistant Auditor, the Deputy Tax Commissioner, and the Tax Specialist shall have their salaries increased by 0% to 5%, which shall be at the discretion of the respective administrative official based on job performance.

Section 2. The Mayor shall determine the raise, within the stated raise range, for the Safety-Service Director, Fire Chief, Police Chief, Police/Court Clerk, and Public Works Supervisor.

The Auditor shall determine the raise, within the stated raise range, for the Tax Office Deputy, Tax Office Specialist, and Assistant Auditor. The salary increase is retroactive to the effective date herein.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to fairly compensate the employees listed above at the earliest possible time.
