ORDINANCE NO. 24-<u>0</u>5

TO SET THE DAILY RATES FOR ADMISSION AND ANNUAL MEMBERSHIP PASS RATES FOR CHEVIOT MUNICIPAL SWIMMING POOL; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to prepare for the sale of pre-season passes to the Cheviot Municipal Swimming Pool, it is necessary to set the daily rates for admission, as well as the annual membership pass costs to be included in the pool brochure; and

WHEREAS, Council believes it is appropriate to amend the rates for the pool as set forth herein.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

<u>Section 1.</u> There is hereby approved a new rate schedule for daily admission at the Cheviot Municipal Pool as set forth below:

<u>Section 3.</u> These rates shall be in effect for the 2024 Pool Season and shall remain in effect until further changed.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to begin sale of pre-season annual passes at the earliest possible time after the pool brochure and membership information is printed.
