

**CITY OF CHEVIOT

**ORDINANCE NO. 18-04**

**TO SET THE RATES FOR PASSES TO THE CHEVIOT MUNICIPAL SWIMMING POOL; AND  
TO DECLARE AN EMERGENCY.**

**WHEREAS**, in order to prepare for the sale of pre-season passes to the Cheviot Municipal Swimming Pool, it is necessary to set the rates for pre-season passes and regular passes.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT,  
STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:**

Section 1. The rates for annual passes to the Cheviot Municipal Swimming Pool, when said passes are purchased prior to the pool opening for that season ("pre-season passes"), shall be as follows:

**Cheviot Residents and Employees of Cheviot Businesses**

Family	\$ 100.00
Couple	\$ 80.00
Adult	\$ 50.00
Youth	\$ 50.00

**Non-Residents**

Family	\$ 215.00
Couple	\$ 140.00
Adult	\$ 100.00
Youth	\$ 70.00

Section 2. The rates for annual passes to the Cheviot Municipal Swimming Pool, when said passes are purchased after the pool opening for that season ("regular passes"), shall be as follows:

**Cheviot Residents**

Family	\$ 145.00
Couple	\$ 100.00
Adult	\$ 70.00
Youth	\$ 55.00

**Non-Residents**

Family	\$ 225.00
Couple	\$ 145.00
Adult	\$ 105.00
Youth	\$ 75.00


**Employees of Cheviot Businesses**

Family	\$ 155.00
Couple	\$ 110.00
Adult	\$ 80.00


Section 3. For pre-season passes and regular passes, a "Family Membership" includes parents and legal dependents under the age of 18 years old, for up to four people. Additional family members are \$10.00 per person.

Section 4. The above-described rates shall be in effect beginning for the 2018 Season and shall remain in effect until further changed.


Section 5. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to begin to sell pre-season annual passes for the Cheviot Municipal Pool at the earliest possible time.




