

**CITY OF CHEVIOT

ORDINANCE NO. 18-25

TO AMEND THE 2018 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, it has become necessary to make adjustments to the 2018 annual budget appropriations by increasing the appropriations for tax refunds; and

WHEREAS, in order to meet certain expenses, it is necessary to adjust the budget appropriations through transfers.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF, CONCURRING, THAT:

Section 1. The following budget line item shall be increased by the amount indicated:

Section 2. The following budget line items shall be decreased by the amount indicated:

101.714.236.1	GENERAL FUND INSURANCE ALL CLASS	\$4,000.00

Section 3. The sum of \$32,000.00 shall be transferred from the General Fund Transfer Out (No. 101.715.270.1) to Sidewalk Transfers In (No. 203.191.1).

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
