TO AMEND THE 2018 ANNUAL BUDGET APPROPRIATIONS; TO TRANSFER CERTAIN FUNDS; AND TO DECLARE AN EMERGENCY.

WHEREAS, in order to meet certain expenses, it is necessary to adjust the budget appropriations through amendments to the 2018 annual budget appropriations and certain transfers.

<u>Section 1.</u> The following budget line item shall be increased by the amount indicated:

<u>Section 4.</u> The sum of \$7,263.00 shall be transferred from the SCMR Fund (201.715.270.1) to PMVT (Fund 205) to correct entry error from 2016.

<u>Section 5.</u> The sum of \$19,600.00 shall be transferred from the General Fund (101.715.270.1) to Police and Fire Pension (Fund 701).

<u>Section 6.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to allow the City to meet its financial obligations in a timely manner.
